Chair's Message

Interest in our mission continues to grow and grow. One measure is the tremendous response to the 2017 "Your Lakes, Your Views Survey. A total of 3291 responses were received - an increase of 1,000 or 44% from our 2013 survey. A tremendous thank you to ERIN Research for donating their services to conduct and analyse the survey. The successful



distribution of the survey could not have happened without our lake association partners, and a special thank you to Ross Halloran of Sotheby's for a dock drop of 8,000 "Take the survey " posters.

Safe Quiet Lakes' emphasis on education, communication and dialogue continues to be endorsed by cottagers, the OPP and politicians. Noteworthy is Muskoka MPP Norm Miller's statement in the Ontario Legislature commending SQL for its work promoting a safe, responsible and respectful boating culture in cottage country. Great Survey Response - Thank-you!



We are thrilled to report that almost 3,300 members of the Muskoka lake community completed the 2017 Your Lakes, Your Views survey. That's an increase of 44% from the 2013 survey and we also received 274 pages of comments, a 90% increase.

This response rate indicates the larger Muskoka lakes community is deeply engaged with the issues covered in the survey .

Thanks to everyone who took the time to participate and to everyone who helped us promote the survey including: the MLA and more than 20 lake associations along with sponsors such as Gordon Bay Marine and Sotheby's.

Safe Quiet Lakes sets our priorities based on the data from the survey, so having such a huge response and a diverse pool of respondents means we will have clear ideas about what is important to the people who use the lakes. The most consistent message is that people care about these lakes. One participant said what is most enjoyable is "Just being at the lake". Many respondents expressed variations on that feeling of love for life on and near the water.

But there are also many deeply felt concerns about what the right balance for use of the lakes should be. So now the task of understanding the data begins. Our research partner ERIN Research (to whom we are enormously grateful) will be sorting through this mountain of information to identify trends and make recommendations. We plan to announce preliminary findings from the report in August and the full report will be available around the end of September.

'Quiet Campaign' joint media event with the OPP



Safe Quiet Lakes was blessed with beautiful weather the Saturday of Victoria Day weekend for its second annual "Quiet Campaign" media event with OPP at the Lake Rosseau side of the locks in Port Carling.

Want to report boating too close to shore, wakes, noise or other safety issues? Call 1-888-310-1122

Driving an unmuffled boat with pipes venting exhaust above the waterline directly from the engine with no muffler, or bypassing the muffler, is illegal on Muskoka area lakes.

Outboard and inboard/outboard engines comply with the law when they exhaust through the propeller hub under water. Loud isn't illegal, but muffler bypassing on our lakes is.

The OPP wants to hear from you. The more info you can provide, the better: photo, description, location, time, and registration number.

Over 65 people drove through bad weather to attend the sixth annual Safe Quiet Lakes stakeholder meeting in Port Carling on Friday April 7th. We wish to thank all of the presenters and attendees for making this our most successful meeting to date.

The meeting featured presentations from key stakeholders, including ERIN RESEARCH representative George Spears who discussed results of the 2013 Safe Quiet Lakes survey and plans for this year's survey. OPP Sergeant Todd Selvage provided an overview of OPP marine activities last year, and WakeBoard Canada representative and Summer Water Sports owner Geordie Newlands explained Transport Canada regulations regarding permits for anything moored to the lake bed (e.g. ski courses, rafts, markers).

Presentations were followed by breakout sessions in which s ix discussion groups explored two important topics:

- incidents on the lakes and,
- boat wakes.

Discussion was animated, and provided valuable perspectives into problems as well as suggestions for creative and concrete solutions.

Ask an Expert - PFDs and the Law

• There must be a Personal Flotation Device (PFD) or lifejacket of an appropriate size and in good working condition for each person on board any pleasure craft, powered or non powered.

- All PFDs or lifejackets must be approved by the Canadian Coast Guard, Transport Canada, the Department of Fisheries and Oceans or any combination of the above. This approval label must be permanently attached or printed on every PFD or lifejacket. PFDs or lifejackets approved by US authorities are NOT approved for use in Canada.
- When the vessel is under way all PFDs and lifejackets must be "readily accessible" which means capable of being reached easily and safely under emergency conditions without the use of tools. Don't keep them stored in a locker when under way. Have them close at hand.
- PFDs and lifejackets cannot be altered in a way that compromises its original structural integrity or diminishes the integrity or readability of it's approval label. If a PFD or lifejacket is badly faded or requires any sort of repair it must be rendered unusable by others, discarded and replaced.
- A PFD or lifejacket that is required by the Small Vessel Regulations does not have to be an appropriate size for an infant who weighs less than 9 kg (20 lbs) or a person whose chest size is more than 140 cm (55 in).
- A PFD or lifejacket that is required by the Small Vessel Regulations may be of an inflatable type only if it is worn at all times when under way.

(a) in the case of an open vessel, by every person on board; and

(b) in the case of a vessel that is not open, by every person on deck or in the cockpit.

- If a PFD or lifejacket that must be carried on board a pleasure craft is to be worn by a person less than 16 years of age or weighing less than 36.3 kg (80 lbs), it shall be inherently buoyant. They cannot use an inflatable PFD.
- A PFD or lifejacket that is required by the Small Vessel Regulations to be carried on board a personal watercraft shall be inherently buoyant. This means that it contains the required amount of floatation material without having to be inflated.
- Lifesaving cushions are not approved as safety equipment on any boat.

Most of the points above are direct quotes regarding Personal Flotation Devices (PFD) or lifejackets taken from the Canadian Small Vessel Regulations. F ines for not having an approved PFD or lifejacket of the appropriate size and in good working condition can be well in excess of \$250 per person. Transport Canada's Safe Boating Guide clearly states:

"A PFD or lifejacket is the best insurance you can have. So, find one that suits your needs and wear it."
