### Chair's Message

We are delighted to announce our "Share the Lakes" Award.

What does "sharing" the lakes mean? The lakes can be thought of as a "commonage", an archaic term for an area used for the shared enjoyment of many people and many activities. But shared enjoyment recognizes that balance is required and one activity should not adversely impact the enjoyment of the collective.

For most people, a boat they find excessively noisy is not "sharing" the lake, its operator is selfishly "dominating" the lake. Our 2017 survey found 88% of over 3,300 respondents ranked "relaxing on the dock" as very important and 82% "like to be able to hear the sound of nature when I am on the lake". Loud boats were ranked as a major obstacle to this basic enjoyment. Last week, our Chair of Advocacy Greg Wilkinson, wrote an OpEd which was published in the Muskokan and distributed by email. Decibels are a measure of sound and decibel limits are used by many countries to regulate boat noise. Canada does not yet have decibel limits, but instead uses an awkward and difficult to enforce requirement for mufflers. Safe Quiet Lakes believes that Canada should adopt regulations based on decibel limits. Over the coming months we will be developing a cooperative approach to advocating for decibel limits, and will provide background on what the options are.

In addition to tackling boat noise, we are also working on programs to address large destructive wakes, speed too close to shore and enforcement.

Night travel on the water is part of life in our lake communities. The terrible accident on Lake Joseph last weekend is a sobering reminder to operate with additional caution at night. You can read our full statement on this [here](#).

## Safety on the Water with the OPP and MLA

New this summer, the Muskoka Lakes Association (MLA) presented a seminar on boating issues. The July 11<sup>th</sup> event in Port Carling was hosted by MLA Community Program Chair Penny Middleton and included presentations from the MLA on their radar study on the Joseph River, Safe Quiet Lakes and the OPP Bracebridge Marine Unit. Time was reserved for a Q&A and the attendees came ready with questions.



The OPP's Sgt Salvage noted that the OPP Marine Unit covers an area with 1,600 lakes with their emphasis on prevention as the most important action they take followed by education and then enforcement. Last year, they conducted 3200 vessel checks in Muskoka and Huntsville area lakes and laid 365 charges. He noted that the Marine Unit relies on the public to alert them to problems on their lakes. He encouraged everyone to call 1-888-310-1122 to report dangerous boating.

**The OPP wants to hear from the community about dangerous boating or boats without mufflers.**

Please call **1-888-310-1122** if you see unsafe, reckless or illegal boating behaviour such as speeding too close to shore, or boats without mufflers.

When reporting, gather as much information as possible by taking detailed notes or video including: boat registration number, colour, make, model, time, frequency and location of the incident and a description of the operator.

Safe Quiet Lakes would like to track complaints to determine trends and identify troubled locations. We meet regularly with the OPP to discuss issues and this kind of information is very useful. [CLICK HERE TO SEND US A COPY OF YOUR REPORT](#)

You must be the complainant. We cannot call the police on your behalf as we were not a witness. Always call 911 in an emergency!

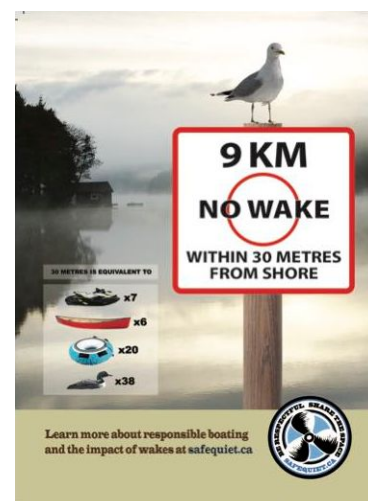
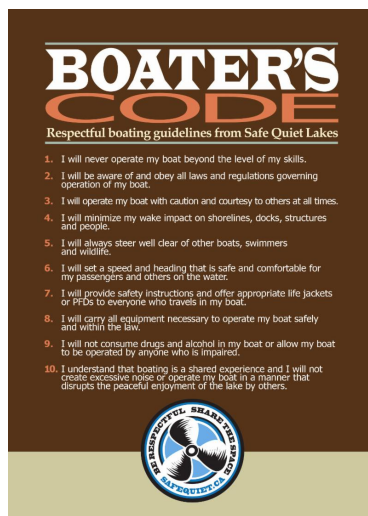
